Objective	Examination of problematic matters of the appeal
Content	<p>This course comprehensively examines the institution of appeal (istinaf), the primary legal remedy against first-instance court decisions in private law disputes. The course content begins by defining the subject, purpose, eligible decisions, and the specific grounds for appeal.</p> <p>It then covers fundamental procedural institutions such as the appeal application, the competent court (Regional Court of Justice), waiver of the legal remedy, and the "prohibition of reformatio in pejus" (prohibition of ruling to the detriment of the appellant). The focal point of the course is the judicial process at the Regional Court of Justice; in this context, the preliminary examination and main examination (examination on the merits) stages are covered in detail. Finally, the decisions that can be rendered at the conclusion of the appeal review (such as dismissal of the appeal, or setting aside the judgment and rendering a new decision) are analyzed in light of current case law and doctrinal debates.</p>
