Objective	<p>This course takes as its object of study political parties that, enjoying one of the longest traditions of study, constitute a structuring subject for political science. Political parties will be apprehended in connection with theories and methods of political science, as proactive part of the political system, but also as "mediators" between the latter and citizens. Through their analysis, is targeted a better understanding of the functioning of representative regimes.</p>
Content	<p>By tracing the outlines of a political sociology of parties, we will first try to make some definitions from which we will place the parties in the political system and present the problematization efforts on emergence, history, functions and future of partisan phenomenon indissociable from liberal democracy.</p> <p>In a second step, we will propose a reading of the parties according to the logic of their project and their position relative to social and political conflicts to reach a classification of political families.</p> <p>We will then analyze legal and internal structures of parties and present the different typologies elaborated on party organizations to reach an explanation of the logic of mobilization carried out by political parties and their links with electoral mechanisms .</p>
