Objective	This course, which covers a period stretching from the Treaties of Westphalia to the beginning of the WWI (thus, from 1648 to 1918) aims at exploring the historical foundations of contemporary politics / international relations. and to ensure the study of the principal dynamics of our era from a historical perspective.
Content	This course, which covers the period from 1648 to 1918, focuses not only on the processes of state formation and construction, but also on the training of contemporary components of international politics. In this sense, its content has a wide range from the determination of the fundamental principles of International Law to the evolution of the international economy. However, the center of gravity, hence, the main actor is The State; as a result, the course examines social movements in the context of state formation and construction processes, as well as principles that govern relations between states and their respective societies. Therefore, this course is committed to presenting wars, turning points, treaties, political, economic and social crises from a coherent and whole perspective. While the study space is early Europe, it extends to the Far East, especially from the 1860s.
